1. Executive Summary



Stankevicius International discovered a lot of issues in the wild commodity market. These issues are being addressed by the top talent developers and analysts. Stankevicius International seeks to solve international trade matters with the help of technology. Business Terminal has been in the constant R&D phase since 2018. The platform requires a lot of data gathering to enable special voice based machine learning solution similar to AI, to create an exclusively unique experience for the end user.

Stankevicius X is working on a new play to earn social media project based in the Metaverse environment. Stankevicius believes that, this new 3D interactive social media world could be a total game changer for the entire social media space where social media goes 3D with gamified experience.

Stankevicius Alternative Investment Banking is developing a special Stankevicius Terminal platform with a special focus on helping companies go public in digital asset markets. The platform provides big financial data. As a matter of fact, it is under consideration to merge both projects, the Business Terminal and Stankevicius Terminal platform together, to make one ultimate big data multi-purpose platform for international clients to manage physical trade as well as online e-trade.

7. Stankevicius Cross-Industry Track Record

Stankevicius has been in the business for nearly a decade and has consulted hundreds of clients worldwide form various industries including reputable companies.

Stankevicius Group has served nearly 600 private clients up to date for different matters from different industries. Majority of the clientele was contracted for public relations and advertising services.
